If you make changes to what you have already filled in, you must sign next to each change.

Sending the switch form

An email delivery receipt is not proof that Alexander Forbes has received the switch form from you. If you have not received confirmation (by sms or email) within **five (5)** working days that your switch form has been received, please contact Alexander Forbes contact centre on 0860 100 333.

You need to make sure that Alexander Forbes has received the switch form. If you have not received confirmation (by sms or email) within **five (5)** working days that your switch form has been received, the switch instruction may not take place.

Conditions regarding switching

Investment portfolio options

Please refer to the Fund's Switching Rules and ensure that the election is made in accordance with the options available to the Fund and its Specific Investment Portfolios. Please note that certain Investment Portfolios have specific rules, such as notice periods and maximum amounts, these rules rank the highest in terms of priority and apply over and above the Fund's switching rules.

Switch fee to be charged

A switch fee may be deducted from the member's current Fund Credit per the Fund's Switching Rules.

Time to make the switch

Investment switches are made within **five (5)** working days of Alexander Forbes receiving the switch instruction, if applicable, in accordance with the time frame prescribed in the Fund's Switching Rules, or, if applicable any specific notice period relating to the Fund's Investment Portfolio/s.

Confirming your switch has been made

Alexander Forbes will send you confirmation that your switch has been made within ten (10) working days of receiving your switch form.

If the switch form is not complete

If the switch form is not complete or not filled in correctly, Alexander Forbes may not be able to make the switch.

Check that the switch has been made properly

You need to advise Alexander Forbes contact centre on 0860 100 333 within 30 (thirty) days if the switch has not been made in the way you instructed and intended.

If the switch is not made

Alexander Forbes will take all reasonable commercial steps to make sure that switches take place within **five (5)** working days. If this does not happen because of an administration error, your money in the fund will be placed in the same position it would have been had the error not been made. This means that the money may be increased or decreased once the error has been corrected.
